Integer.Systems Privacy Policy

Integer Systems collects the e-mail addresses of people who send us e-mails. We also collect information on what pages users access and information provided to us by users via surveys and site registrations. Such information may contain personal data about you including your address, phone numbers, credit card numbers, etc. We are not allowed to disclose such personal information without your written permission. However, certain information collected from you and about you is used within the context of providing the Service. The information we collect is not shared with or sold to others except under the certain circumstances and which your use of the Service is deemed to provide to us a valid consent to disclose the following:

In order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Integer Systems' terms of use, or as otherwise required by law.

Integer Systems does not rent, sell, or share personal information about you with other companies except to provide products or services you've requested or when we have your permission.

We will transfer information about you if Integer Systems or Integer Systems is acquired by or merged with another company. In this event, Integer Systems will notify you by email or by putting a prominent notice on the Integer Systems website before information about you is transferred and becomes subject to a different privacy policy.

What we do with your information

When you register for Integer Systems we ask for your name, email address, billing address, and credit card information. Integer Systems uses the information we collect for the following general purposes: products and services provision, billing, identification and authentication, services improvement, contact, and research.

As part of the buying and selling process on Integer Systems, you may obtain the email address and/or shipping address of your customers. By agreeing to our Terms and Conditions (Terms of Service), you agree that, with respect to other users' personal information that you obtain through Integer Systems or through an Integer Systems related communication or Integer Systems facilitated transaction, Integer Systems hereby grants you a license to use such information only for Integer Systems related communications that are not unsolicited commercial messages. Integer Systems does not tolerate spam. Therefore, without limiting the foregoing, you are not licensed to add the name of someone who has purchased an item from you to your mail list (email or physical mail) without their express consent.

Security

The security of your personal information is important to us. When you enter sensitive information, such as credit card numbers on our registration form, we encrypt that information using secure socket layer technology (SSL). We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it. No method of transmission over the Internet, or method of electronic storage, is 100% secure, however. Therefore, while we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security.

Integer Systems transactions and operations are PCI compliant. Integer Systems works only with payment gateways and vendors that are 100% PCI compliant.

To protect Personally Identifiable Information (PII), we use Standard 128-bit SSL Encryption to protect the data stream between the user's browser and our servers. Storage of PII data is further encrypted using a combination of hashing, encryption, and data scrambling. The data network is secured and monitored 24 hours a day, 7 days a week.

Cookies

A cookie is a small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a website's computer and stored on your computer's hard drive.

Integer Systems uses cookies to record current session keys only. Private and sensitive information is never stored in these session cookies and they generally last two weeks. You are required to log in to your Integer Systems site after a certain period of time has elapsed to protect you against others accidentally accessing the content of your account.
